

# Privacy Policy

---

Eonsfleet understands that privacy is an important concern of visitors to our website located at [www.Eonsfleet.com](http://www.Eonsfleet.com). This Privacy Policy is intended to inform you of our policies and practices regarding the collection, use and disclosure of any information you submit to us through our website or we collect as a result of your visit to our website so you can obtain the level of privacy you prefer.

## User Consent

By accessing our website, you agree to the terms of this Privacy Policy. You also consent to being contacted by Eonsfleet unless you email Eonsfleet requesting that it not contact you or your organization.

## Personal Information

"Personal Information" means information that allows someone to identify or contact you, for example, your name, address, telephone number, e-mail address, as well as any information about you that is associated with or linked to any of the foregoing information.

## Anonymous Information

"Anonymous Information" means information that does not directly identify you individually. We collect Personal Information and Anonymous Information, as described in the following sections.

## Types of Information We Collect

Eonsfleet collects Personal Information or Anonymous Information from you when you visit our website or through social media platforms. Should you choose not to provide any of the requested information, you might not be able to take the advantage of some of our services. We collect and use the minimum information to respond to your requests.

We may store some of information whenever you interact with us. For example, we use cookies and web beacons to obtain information whenever you visit 'www.Eonsfleet.com'.

Please refer to below example describing the information collected from visitors to our website

### For visitors who are interested in learning more about our products, support, or services:

- Name
- E-Mail address
- Name of employer
- How you heard about Eonsfleet
- Contact information
- Brief about their business need

### For visitors who wish to provide feedback to Eonsfleet:

- E-Mail Address
- Comments on software, support or services
- Comments on website

### For visitors who want further information about Eonsfleet:

- Contact Information (name, email address, phone number)
- Company name
- Subject of e-mail
- Message and any information contained therein
- Type of inquiry: developer, licensor, distributor, other

### **For all other visitors who e-mail us directly via an e-mail hyperlink:**

- E-mail message, which includes any information contained in the message, including information that can be collected by technological means.

We might receive information about you from other sources (for example: information received from third parties or website visitors) and add it to our database.

### **Personal and Anonymous Information Collected Via Technology**

To make our services more useful to you, we use technological means or tools to collect Personal Information, as well as Anonymous Information, from you. These tools collect certain standard information that your browser sends to our website, including domain names, your browser type and language, and your Internet Protocol (IP) address and access times. You expressly consent to our collection of such information by using the Eonsfleet website. An "IP address" is a number that is automatically assigned to your computer when you use the Internet. In some cases your IP address stays the same from browser session to browser session; but if you use a consumer Internet access provider, your IP address probably varies from session to session. We track IP addresses to analyze our Web page flow.

**Cookies and Web Beacons:** In particular, we use, as do many other websites, "cookies" or small data files stored on your computer's hard drive, as well as "web beacons" which are images invisibly embedded on a web page, to collect information during visits to the Eonsfleet website, including during chat sessions with Eonsfleet personnel. The information collected includes the visitor's IP address, when the site was visited and what pages were visited. In some instances, we also use cookies to collect information in connection with future visits from that website, to recognize you as a previous visitor, or to track your activity on our site. If you follow a link to the site from an affiliate or promotion, we store information about your arrival from that affiliate or promotion in a session cookie. You do not need to have cookies turned on to visit our site. You can refuse cookies by turning them off on your browser. But, if you want to access webpages that require registration, you need to accept a mandatory session cookie, which you can delete after you leave the site. Web beacons, which record your IP address and the time of your visit and what pages you viewed, and are used by a third party service which tracks site usage for us, cannot be turned off. For more details please refer to our cookie policy

### **Identification of Visitors to Site:**

We are able to identify you from the Personal Information that you submitted in the past or that you submit on a current visit. We are also able to identify you or your organization from other information obtained by technological means, such as browser you are using or the pages on the Eonsfleet site you visit. This data is now tracked by a third party service and provided to us in aggregate form by that service.

### **Use of Personal Information**

In general, Personal Information you provide to us or that is obtained by technological means is used to respond to requests that you make, to facilitate communication with you that you initiate or request or to provide you with information about products and services of Eonsfleet in which you indicate an interest. For example, we may use your Personal Information to process an employment application, should you submit one to us. We also use your personal information to send you electronic newsletters and promotional e-mails if you have requested to receive such communications from us (as described below). We use Personal Information to provide you with updates to our services and to respond to your requests.

## **Disclosure of Personal Information**

We do not generally sell, trade, rent, or share your Personal Information with third parties. However, we may share your Personal Information with third parties to fulfill your request for products or services or to deliver newsletters or promotional e-mails.

We employ other companies and individuals offer to perform functions on our behalf. Examples include sourcing of customer lists, analyzing customer data, providing market intelligence, lead generation etc. They have access to personal information needed to perform their functions defined in contracts but may not use it for other purposes.

These third parties are required not to use your Personal Information other than to provide the services requested by Eonsfleet. The privacy notice provided to you at the time of collection will include details about the personal data that is shared with third parties and the purposes for which it will be used

Eonsfleet may use or disclose your Personal Information, User Data and other information if required to do so by law or in the good faith belief that such action is necessary to

- be in compliance with legal obligations
- protect and defend the rights or property of Eonsfleet or its affiliates
- to protect the personal safety of users of the Site or the public in urgency like situations
- for protection against legal liability.

We only provide your personal information to third parties when we believe it is appropriate to comply with the law; enforce or apply our agreements; or protect the rights, property, or safety of Eonsfleet, our users, or others.

## **Future Communications and Use of Personal Information**

If you opt-in to receive communications from us (as described below), we will periodically send you free newsletters and e-mails that directly promote the use of our site or our products or services, and use the contact information you provide to us to do so. If you would like to cease receiving these communications from us, you may unsubscribe by sending an email to us.

## **Sharing Information with Affiliates**

We may share some or all of your Personal Information with our subsidiaries and other affiliates, without requesting your specific consent to such internal sharing. If Eonsfleet and/or its assets are acquired by another company, you will receive a notice stating the acquiring company will possess the Personal Information collected by us and it will assume the rights to use and the obligations to protect your Personal Information as in accordance with this Privacy Policy. You can also choose to not to provide your information with affiliates by notifying us through emails.

## **Use and Disclosure of Anonymous Information**

Except as required by law or court order, Eonsfleet will not disclose any of your Personal Information linked to Anonymous Information to any third party. Anonymous Information is usually only used by Eonsfleet in aggregated, rather than in individual form, to determine and analyze such things as site usage, the popularity of pages on the site traffic patterns of site visitors and the like. Eonsfleet may use Anonymous Information to identify your organization and contact that organization based on public information about the organization. Such identification and/or contact can be prevented by sending an email to us.

## **Legally Required Disclosure of Personal and Anonymous Information**

We may disclose your Personal Information if we believe in good faith that such disclosure is necessary to (a) comply with relevant laws or to respond to warrants served on Eonsfleet; or (b) protect and defend the rights or property of Eonsfleet or users of our website. To the extent required by applicable law or by subpoenas or warrants served on Eonsfleet court orders, we

reserve the right to combine Anonymous Information with Personal Information that you actively submit or other information obtained through technological means to identify you.

### **Your Choices Regarding Personal Information and Future Communications**

We offer visitors to Eonsfleet's website choices regarding the use and sharing of your Personal Information. Please send an email to us if you have special requests.

When you send a request for information on our site, we will ask you if you want to receive future communications from us. You may indicate consent to receipt of these communications by checking the boxes located on the account creation form. Should you decide to stop receiving further communications from us, you will have the opportunity to "opt-out" by following the unsubscribe

instructions provided in the e-mail you receive, or by sending an email to us. If at any time you wish to subscribe to any communications from us, you may visit our website and sign up for this service. Notwithstanding your indicated e-mail preferences, we may send you notices of any updates to our Terms of Service, Privacy Policy, or products or services.

### **Information Access Rights**

### **Security of Personal Information**

We use reasonable measures to maintain the security of your Personal Information. Eonsfleet has implemented industry-standard electronic means of protecting your Personal Information. We store Personal Information behind a computer firewall, a barrier designed to prevent outsiders from accessing our servers. In addition, Eonsfleet protects your Personal Information from unauthorized physical access by storing your Personal Information in a controlled facility. Except as provided elsewhere in this Privacy Policy, Eonsfleet limits access to Personal Information in electronic databases to those persons (including employees and contractors) in Eonsfleet' organization who have a business need for such access. Even though Eonsfleet has taken significant steps to ensure that your Personal Data is not intercepted, accessed, used, or disclosed by unauthorized persons, you should know that Eonsfleet cannot eliminate security risks associated with Personal Data.

We secure your information during transmission by encryption.

### **Privacy Policy Revisions and Updates**

This Privacy Policy is subject to revision, and if we make any substantial changes in the way we collect, use, or disclose your Personal Information, we will post a notice on this page or send the periodic reminders of our notices and conditions. If you object to any such changes, you must cease using our website. Unless stated otherwise, our current Privacy Notice applies to all information that we have about you and your account. Continued use of our website following notice of any such changes shall indicate your acknowledgement of such changes and agreement to be bound by the terms and conditions of such changes.
